How You Can Help -

Gifts of all sizes and types help to make our hospital stronger. There are numerous ways you can invest in Samaritan's future with a contribution to the Samaritan Medical Center Foundation.

Below are just a few suggestions:

Memorial/Tribute Gifts

Honor or remember a special relative, friend, neighbor or co-worker. Gifts are given to provide a meaningful and lasting memorial, or to celebrate a special occasion or accomplishment. Notification is sent to the honoree or, in the case of a memorial gift, to the family.

Cash

A gift of cash is the simplest and most immediate way people contribute to the Samaritan Medical Center Foundation. Cash gifts may also be pledged over the course of several years.

Planned Giving

Planned giving is simply a deferred donation, arranged well ahead of time, usually through wills, life insurance, charitable trusts, or gifts of property or stock.
