SMC ADVANCED CARDIAC LIFE SUPPORT 2019

Course Description:

These courses meet the standards of the American Heart Association for the training of providers in ACLS. The goal of these sessions is to integrate knowledge and motor skills into a clinically useful discipline. The courses are designed to develop skills and proficiency in the techniques of ACLS. The latest guidelines and recommendations of the American Heart Association are emphasized. The material is covered through hands-on small-group approaches and case scenarios. *Previous Basic Life Support Training and proficiency in cardiac rhythm interpretation, pharmacology, and venipuncture experience is required.*

Successful completion of ACLS consists of adequate performance in the following areas:

- 1. Basic Life Support
- 2. Recognition and treatment of cardiopulmonary arrest/rhythm disturbance
- 3. Management of Airway
- 4. Obtaining a passing score of 84 on the written examination
- 5. Successful performance as a team leader in a code

Class size is limited to 14 participants. You must present your current ACLS card to gain access to the Renewal Class. If your card has expired, you may take the Renewal Class, but will not be allowed remediation.

It cannot be emphasized enough that for the maximum benefit and the greatest success in the course, participants should be well prepared:

- 1. Per AHA, each participant must have access to the ACLS 2015 provider manual before, during and after class.
- 2. There will be manuals on reserve for Samaritan employees in the SMC library.
- 3. The on-line pre-test must be completed prior to admittance to class. You must bring your pre-test score printout to class.
