## **Healthcare Provider Course Description:**

The BLS for Healthcare Providers course is designed to teach the skills of CPR for victims of all ages (including ventilation with a barrier device, a bag-mask device, and oxygen), use of an automated external defibrillator (AED), and relief of foreign body airway obstruction (FBAO). It is intended for participants who work in a healthcare setting and those who are required to take a healthcare provider course for their employment or for school.
