

Patient Visitation Guidelines

- Four Visitors at a time for adult inpatient units, no limit of total Visitors per day, from 8:00am 8:00pm (exceptions noted below)
- For any patient on isolation precaution their visitors must wear appropriate PPE while in the Hospital
- Any patient under 21 may have two parents/guardians present
- All Visitors must be over 12 years of age (exceptions noted below)
- Visitors/Support Persons, including Clergy, must check in and check out via the Main Lobby or Car-Freshner Center for Women and Children (when appropriate)
- All Visitors/Support Persons must wear a hospital-issued identification badge, indicating the correct color of the day
- Anyone may visit the cafeteria, coffee shop and gift shop while in the Hospital all public wishing to use these entities must also check in at the Main Lobby
- Samaritan Medical Center may restrict visitation for any visitor exhibiting any signs of illness (ie. fever, vomiting, and/or diarrhea). We encourage any person not feeling well to postpone their visit to the hospital until they are feeling better.
- If a staff member is visiting a patient (on or off-duty), they must also check in at the Main Lobby.

Continuous Visitation Exceptions:

- Patients with cognitive impairments (ie. Dementia), intellectual and/developmental disabilities and sensory or physical impairments Two (2) Support Persons can be present at all times
- Patients at End-Of-Life/Comfort Measures: Six (6) total Visitors/Support Persons at a time during general visiting hours of 8 a.m. 8 p.m. Two (2) support persons patients may be present at all times. Compassionate exceptions are approved by the Charge Nurse and Nursing Supervisor.

| Outpatient Testing/Clinics/Medical Practices/Walker Center for Cancer Care | Unrestricted | 2 | No |
| Outpatient Infusion Unit | Unrestricted | 1 | No |
| Surgical Unit | Unrestricted | 2 (1 in pre and post operative areas only) | No |
